Undergraduate in-course Bursaries of \$2,283 were awarded to: Marie-Pier Caron, BA (Spec. Traduction, Minor Modern Chinese Language (Mandarin) & Culture); Erik Hutt, BFA (Major Film Production); Alexandra Meikleham, B.Eng. (Civil); Kelvinder Singh B.-Com. (Major Accountancy, Minor Modern Chinese Language (Mandarin) & Culture).

The letter also included copies of nine thank you letters to us as donors which had been received by the Advancement office. The students are very, very appreciative of this financial help and the encouragement and recognition it provides, as shown in the continuation of this article in the online section of this newsletter.

For the current year 2014-15, it is anticipated that the level of support provided by the Retired Faculty and Staff Scholarships and Awards Endowment Fund will be about the same as last year. To maintain, let alone raise the amount of support this fund provides, or to increase the number of awards made, the fund needs to grow. ## UEST SPEAKER - KRISTA BRECHT

---

The Guest Speaker at our General Meeting, October 30, was Ms. Krista Brecht, a registered nurse with experience in pain management and palliative care. Ms. Brecht gave an excellent and well-received presentation on the nature of pain and of pain management, something which is becoming an all-to-familiar issue as time goes on.



A summary of the talk, given to us by Ms. Brecht is as follows:

*Ageing and pain is a process that converts healthy adults into frail ones with diminished reserves in most physiologic systems and an exponentially increasing vulnerability to most diseases. Pain should not be seen as an intractable symptom in isolation but rather should be approached as part of a group of changes that together predict worsening health status and decreased ability to respond to stressors. We will discuss some general principles and statistics of pain in the older adult; identify multiple pain conditions affecting the older adult; define consequences of pain; and explore assessment, management strategies along with community resources.*

We thank Krista again for sharing her time and knowledge with us.

## ENSION FUND REPORT

The pension fund ended the year 2013 with a total of \$779.147M in net assets.

The return achieved in 2013 was 13.1%. This is higher than the objective of 6% which also represents the rate at which the Plan's liabilities are discounted.

The new actuarial valuation adopted on December 31, 2013 has incorporated the newly designed Canadian mortality tables released by the Canadian Institute of Actuaries. The tables show improved longevity compared to the ones used previously that were based on American data. On the other hand, this change alone caused the actuarial liabilities of the Plan to increase by 5%.

The consequence of it was that, in spite of the excellent return achieved in 2013, the Plan is still underfunded by about \$109.7 million which implies a funding ratio of 87.7%.

For much of 2013 and 2014 the Pension Fund has and is still being transitioned to a new asset allocation adopted by the Pension Committee in February 2013.

This new investment policy is expected to

- reduce volatility in terms of annual investment returns, while offering high liquidity levels
- stabilize funding status and funding costs, and
- minimize capital losses in case of a significant market fluctuation

Finally, improved governance structures have been put in place to ensure close monitoring of the investment portfolio and the risks.

## ENEFITS REPORT

It should be stated at the outset that the interest of retirees (and your reps) in all the discussions below is limited to the possibility of the cancellation of our current pension indexation to the cost of living. No other reduction in retiree benefits is mentioned anywhere by the Quebec government or by Concordia's "Principles". But the issue is crucial to our pensions: at an annual cost-of-living increase of only 2 percent, cancellation of indexation would result in the reduction of each pension's purchasing power of about 30% over time.

This report covers the latest meeting of the University Benefits Committee (at which it was confirmed that retirees' premiums for health and other non-pension benefits would not be increased for 2014) and the meetings of two other newly-created groups, all related to the crisis in pension benefits and contributions initiated by the Quebec Government's Bill 3, which applies to Quebec municipalities, but is forecast to be applied in later form to universities.

The first new Committee is the Benefits Committee Working Group (which excludes some of the Benefits Committee's administrative members). This Committee was briefed by Administration on the implications of Bill 3's reduction of municipal employees' pension benefits, and increase in employee contributions, in order to reduce deficits: the briefings involve the possible application of these changes to universities. The Working Group is discussing these details with a view to developing a satisfactory formula for these changes at Concordia. The conclusions will be in the form of suggestions to the Benefits Committee proper.

The other new group, the pension Sustainability Forum, includes all the pension "stakeholders": representatives from all the Concordia unions, as well as we retiree reps, and is led by University administrators in this area. The Forum was also briefed on the Bill 3 changes, and the possible applications of the changes to Concordia. In the last of these sessions, in early December, this group will also be developing some suggested changes to the Concordia pension formula to be forwarded to the Benefits Committee. As this group involves all the university's unions, the focus of the suggestions will possibly be somewhat different from those of the Working Group.

Finally, the Benefits Committee proper, which, with the input of the other groups' suggestions, will develop a final report of recommendations on this issue for presentation to the Board. The goal is for Concordia to have a plan ready to counter the new Government bill for Universities early in 2015.

The major issue confronting retirees is one of the "Principles" put forward in the briefings by the Administration is that retiree indexation "MUST" be cancelled—for all time. This is not stated in Bill 3, which leaves open the choice of cancelling the indexation of current retirees to the decision of each municipality. Bill 3 does insist on the cancellation in perpetuity of all active employees' indexation.

We have strongly objected each time it comes up, pointing out not only the "choice" allowed by Bill 3, but also the Supreme Court Dyson decision of 1993, which forbids any reduction or removal of retirees' pension-(or any other)-benefits, because we have "earned them".

What chance have we to succeed in this endeavour to resist indexation cancellation? We are not sure, particularly since the Quebec Government's Bill on University pensions will not appear until sometime early next year. Meanwhile we soldier on.

This report outlines initiatives which have been implemented on a gradual basis over the past year and half.


CUPARUC's primary goal at this time is to increase membership in the Association. We have achieved some success through the joint efforts in place, although there remain a large number of retirees who are not members.

The challenge is to reach out to retirees who are not members, from our end, rather than wait, hope, and expect that they will reach out to us. Since we do not have direct access to contact information for these non-members we rely very much on the Human Resources Department of the University, which has provided substantial assistance as a liaison between the retiring employee and CUPARUC.

The current practice is that the following documents are provided to newly retiring employees: at the time of sign-off with the Human Resources Department; as enclosures with mass mailings originating from the Human Resources Department; as hand-outs at seminars or workshops hosted by the University; ie. Retirement Planning; Voluntary Departure Programme.

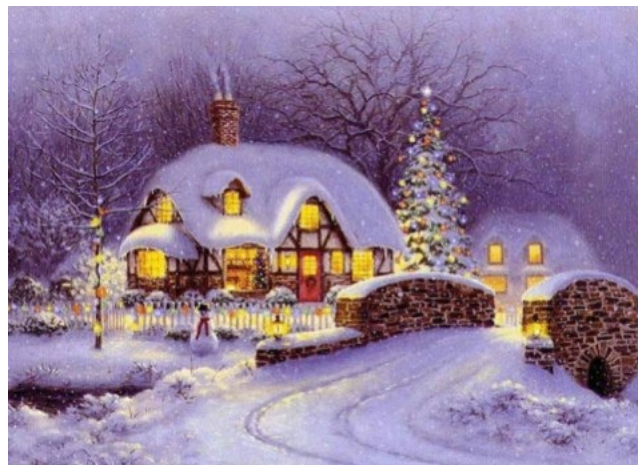
This documentation has been designed specifically to provide information on the benefits of becoming a member of the Pensioners Association (CUPARUC).

**Urgent      University Pension Committee Election      Urgent**

Monday, December 15<sup>th</sup>, 5:00 pm, H765

At the September 29<sup>th</sup> University meeting concerning Concordia's pension plan, there was a nomination from the floor for the pensioners/inactives seat on the University Pension/Benefits Committee; this was in addition to the nominations from your Concordia University Pension Association. While unusual, the rules do allow for such nominations.

CUPARUC's nominees were **Howard Fink** (who has many years of experience in pension and benefits operations and issues) as pension/benefits committee member and **George Tsoublekas** (who has a background in economics and banking) as alternate. Over the last couple of years, the investment strategy orientation of the pension plan has undergone a substantial shift, which involved many hours and days of learning and deliberation as well as the vetting of new investment managers. Both Howard and George were very active in this work, and we feel their continuing involvement in the committee is important to the ongoing task of vigilant oversight of how the new investment strategy is functioning. Moreover, both are knowledgeable about the current Quebec Government initiatives to change public pension plans, and have been helping us to understand the possible implications for us.

We urge you to come to the **December 15<sup>th</sup> Pension meeting** to **vote**, and we strongly recommend that you support the nominees of your pension association.
